WARRANT AND COVENANT that no assignment, grant, security interest, license or other agreement or encumbrance affecting the rights and property herein conveyed has been or will be made or entered into by Assignor, and that the full right to convey the same as herein expressed is possessed by Assignor;

COVENANT, when requested and at the expense of Assignee, to carry out in good faith the intent and purpose of this Agreement, to execute all reissue, reexamination,


