
- The Inventions and all rights in any country in the world with respect to the Inventions;

- Any and all other rights and interests arising out of, in connection with, or in relation to the Inventions, Applications and Patents.

Assignors request the respective patent office or governmental agency in each jurisdiction to issue any and all patents, certificates of invention, utility models or other governmental grants or issuances that may be granted upon any of the Rights in the name of Assignee, as the assignee to the entire interest therein.

The terms and conditions of this Assignment will inure to the benefit of Assignee, its successors, legal representatives and assigns and will be binding upon Assignors, their successors, legal representatives and assigns.
