ASSIGNMENT

WHEREAS, CRAIG PETERSON residing at 835 SHADWELL DRIVE, HOUSTON, TEXAS 77062; JOSEFINA CHAPMAN residing at 15427 ROCKY OAK COURT, HOUSTON, TEXAS 77059; R. JAY WARNER residing at 3507 EAST PINE BROOK WAY, HOUSTON, TEXAS 77062 and MARK SCATES residing at 18117 SANDY COVE, HOUSTON, TEXAS 77058 (hereinafter referred to as ASSIGNORS), have invented certain new and useful improvements in PROCESSES FOR PRODUCING ACRYLIC ACIDS AND ACRYLATES (hereinafter referred to as THE INVENTION) for which an application for United States Letters Patent was filed on, March 15, 2012, as Serial No. 13/420,787.

ALSO, ASSIGNORS hereby agree to execute any documents that legally may be required in connection with the filing, prosecution and maintenance of said application or any other patent application(s) or inventor certificate(s) in the United States and in foreign countries for said invention, including additional documents that may be required to affirm the rights of ASSIGNEE in and to said invention, all without further consideration. ASSIGNORS also agree, without further consideration and at ASSIGNEE's expense, to identify and communicate to ASSIGNEE at ASSIGNEE's request documents and information concerning the invention that are within ASSIGNOR's possession or control, and to provide further assurances and testimony on behalf of ASSIGNEE that lawfully may be required of ASSIGNORS in respect of the prosecution, maintenance and defense of any patent application or patent encompassed within the terms of this instrument.

ASSIGNORS also agree, without further consideration and at ASSIGNEE's expense, to transfer the right to sue for past infringement to ASSIGNEE and at ASSIGNEE's request documents and information concerning the enforcement of the right to sue within ASSIGNORS possession or control, and to provide further assurances and testimony on behalf of ASSIGNEE that lawfully may be required of ASSIGNOR in respect of the right to sue of any patent encompassed within the terms of this instrument.

ASSIGNORS' obligation under this instrument shall extend to ASSIGNOR's heirs, executors, administrators and other legal representatives.

ASSIGNORS hereby grant the firm of Roberts Mlotkowski Safran & Cole the power to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.

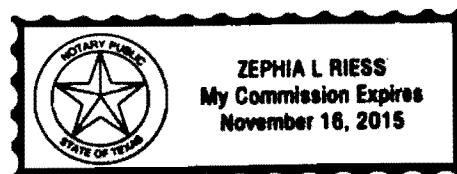

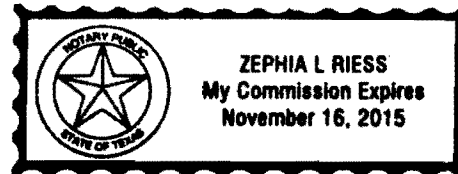

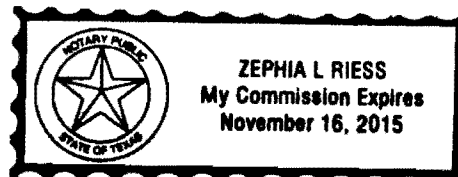
