ASSIGNMENT

WHEREAS, We, Paul V. Goode, Jr., a United States citizen, residing at 39724 Via Las Palmas, Murrieta, CA 92563; James H. Brauker, a United States citizen, residing at 10831 Riesling Drive, San Diego, CA 92131; Apurv U. Kamath, a United States citizen; residing at 143 South Rios Avenue, Solana Beach, CA 92075; and James P. Thrower, a United States citizen, residing at 10694 Caminito Alvarez, San Diego, CA 92126, have invented certain new and useful improvements in a SYSTEM AND METHODS FOR PROCESSING ANALYTE SENSOR DATA for which we have filed an application for Letters Patent in the United States, Application No. 10/633,329 filed on August 1, 2003;
