which may be incurred by said Assignor in lending such assistance and cooperation shall be paid by the Assignee.

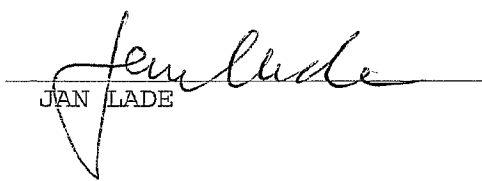

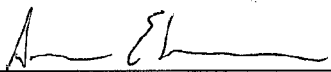
