WHEREAS, we are the joint inventors of certain new and useful improvements in **SIC DEVICES WITH HIGH BLOCKING VOLTAGE TERMINATED BY A NEGATIVE BEVEL**, for which we have applied for Letters Patent of the United States on February 6, 2012, Application Serial Number 13/366,658, a Continuation-in-Part of Application Serial Number 13/108,366 filed May 16, 2011, and for which we have executed a declaration.

We hereby request the Commissioner for Patents to issue the Letters Patent in accordance with this instrument.
