The terms and condition of this Assignment will inure to the benefit of Assignee, its successors, assigns, and other legal representatives and will be binding upon Assignor, its successors, assigns, and other legal representatives.

Without derogating from the above, Assignor hereby irrevocably appoints Assignee, its successors and assigns, as its true and lawful attorneys empowering Assignee to take all actions, execute all acts, deeds, matters and things, including but not limited to signing all documents necessary, for completing assignment the Patent Applications and recording same with any Patent office around the world.
