

## TERMINATION OF PATENT COLLATERAL AGREEMENT

Gold Tip, LLC, a Delaware limited liability company ("Debtor"), with its principal place of business and mailing address at 368 South Gold Tip Drive, Orem, Utah 84058, and Bank of American Fork, a Utah corporation ("Secured Party"), with its mailing address at 1280 South 800 East, Orem, Utah 84097, entered into that certain Security Agreement, dated January 14, 2009 (the "Security Agreement"), whereby Debtor granted to Secured Party a continuing interest in certain patents, patent applications, and all proceeds thereof (the "Collateral"), as more particularly set forth in the Security Agreement. Debtor and Secured Party also executed a Patent Collateral Agreement, also dated January 14, 2009, and recorded with the United States Patent and Trademark Office on January 15, 2009, Reel/Frame: 0022109/0224, docket Number 8901811 (the "Patent Assignment"), whereby Debtor acknowledged, assigned, mortgaged and pledged to Secured Party a continuing security interest in the Collateral, which Collateral also is described in the Patent Assignment and also is described in Exhibit 1 attached hereto.

BANK OF AMERICAN FORK, the Secured Party under both the Security Agreement and the Patent Assignment, acknowledges that the indebtedness secured by the Security Agreement has been fully satisfied and hereby terminates and releases its security interest and all of its right, title and interest in the Collateral and under the Patent Assignment.
