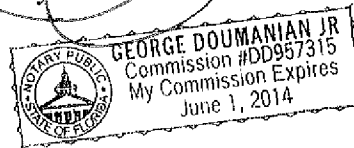

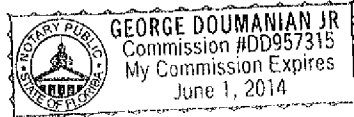



Title of Invention: **TIME-VARIANT SCHEDULING OF AFFINITY GROUPS ON A MULTI-CORE PROCESSOR**




