

**DOES HEREBY CERTIFY:**

**FIRST:** That resolutions were duly adopted by the Board of Directors of the Corporation setting forth a proposed amendment of the Certificate of Incorporation of the Corporation, as amended and restated, declaring said amendment to be advisable and directing that such amendment be submitted to the stockholders of the Corporation for consideration thereof at the Corporation's next annual meeting of stockholders. The resolution setting forth the proposed amendment is as follows:

**RESOLVED**, that Article First of the Corporation's Certificate of Incorporation be amended and restated in its entirety to read as follows:

"First. The name of this corporation is AFCell Medical, Inc."
