Attached hereto as Schedule A is a list of US patents owned by Datalogic Automation S.r.l.

The patents listed in Schedule A were originally assigned to Escort Memory Systems (“EMS”) of Scotts Valley, California. The Assignments were recorded in the USPTO as indicated on Schedule A.

On information and belief, EMS was purchased by Datalogic S.p.A. in 1989.

On information and belief, EMS changed its name to Datalogic EMS, Inc. in 1991.

On information and belief, Datalogic S.p.A. merged EMS with Datalogic Optic Electronics, a wholly-owned subsidiary of Datalogic S.p.A.

On information and belief, in 1997 Datalogic EMS, Inc. changed its name to Escort Memory Systems.

On information and belief, in December 2007 the intellectual property assets of Escort Memory Systems, including the patents listed in Schedule A, were transferred to Datalogic Automation, S.r.l.


