WHEREAS, I, Roland J. I hereby authorize and request the United States Commissioner of Patents and Trademarks, and such Patent Office officials in foreign countries as are duly authorized by their patent laws to issue patents, to issue any and all Letters Patent on said invention to the said Assignee as the owner of my entire interest, for the sole use and behoof of the said Assignee, its successors, assigns, heirs and legal representatives, to the full end of the term for which said Letters Patent and any reissues or extensions thereof may be granted; as fully and entirely as the same would have been held by me had this assignment and sale not been made.
