DECLARATION IDENTIFYING ERROR IN ASSIGNMENT AND REQUESTING CORRECTION UNDER MPEP 323.01(b)

Sir:

I, HARRY WHALEY, declare that:

1. I am the president of Woodstream Corporation (“Woodstream”).
2. On March 26, 2006, Perky-Pet Products Co. was merged with and into Woodstream, with Woodstream being the surviving corporation. The Certificate of Ownership and Merger for this transaction was recorded with the U.S. Patent and Trademark Office on September 25, 2006 at Reel 018303, Frame 0042.
3. An executed Assignment of Application No. 10/907,526 from inventors Lynn Hunter, James Carter, Furman O’Dell, and Brian K. Krueger to “Perky-Pet Products Company, Inc.” was

recorded with the U.S. Patent and Trademark Office on September 19, 2005 at Reel 016995, Frame 0131.

4. The executed Assignment includes two errors of a typographic nature, for which correction is requested.

5. The first error is that the correct name of the Assignee is "Perky-Pet Products Co.," but the name of the Assignee was incorrectly typed as "Perky-Pet Products Company, Inc."

6. The second error is that the name of one of the inventors, Krueger, was omitted due to typographical error in six of the eight places in which the inventors are listed (all four of the inventors are correctly listed in the first paragraph of the Assignment and in the final list in which the inventors inserted their signatures).

7. Inventor O'Dell has initialed a corrected copy of the Assignment and a copy of the initialed Assignment is attached as Exhibit A.

8. Inventors Hunter, Carter, and Krueger are no longer affiliated with Woodstream. They were written to and requested to initial and date a corrected copy of the executed Assignment. They have not responded.

9. Woodstream, as the successor in interest to Assignee Perky-Pet Products Co., accordingly requests that it be permitted to correct the Assignment in place of inventors Hunter, Carter, and Krueger.

10. The following additional documents are submitted herewith:


