ASSIGNMENT

And I do hereby authorize and request the Commissioner of Patents to issue all Letters Patent of the United States that may be granted claiming priority from the application aforesaid, or for said invention, to said ASSIGNEE, its successors and assigns, in accordance with this assignment.
