
ASSIGNMENT

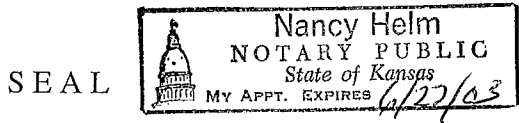

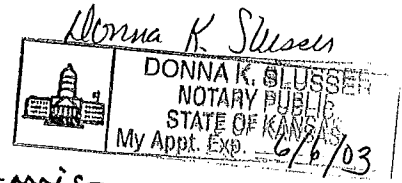
