ASSIGNMENT OF INTELLECTUAL PROPERTY

This is an Assignment of Intellectual Property (this "Assignment") made effective as of the 21st day of May, 2012 by and between Hollywood Tans Brands, LLC, a Delaware limited liability company, and Hollywood Tans Group, LLC, a Delaware limited liability company (collectively the "Assignors"), and HT Branding, LLC, a Delaware limited liability company (the "Assignee") as the designee of Hollywood Tans Acquisition Group, LLC, a Delaware limited liability company (the "Acquisition Company").

RECITALS

WHEREAS, Assignors, the Acquisition Company, and others are parties to that certain Disposition Agreement of even date herewith (the "Agreement"), pursuant to which Assignors have agreed to sell to Assignee, and the Acquisition Company has agreed to accept from Assignors the Transferred Assets (as defined in the Agreement), including, without limitation, all Intellectual Property (as defined in the Agreement).

WHEREAS, pursuant to Section 5.03 of the Agreement, Assignors have agreed to execute such instruments as the Acquisition Company may reasonably request in order to more effectively assign, transfer, grant, convey, assure and confirm to the Acquisition Company and its successors and assigns, or to aid and assist in the collection of or reducing to possession by the Acquisition Company of, all of such Transferred Assets, including, without limitation, all Intellectual Property.

WHEREAS, the Acquisition Company designated the Assignee to acquire all of its right title and interest in and to Assignor's Intellectual Property under the Agreement.

WHEREAS, in accordance therewith, Assignors desire to transfer and assign to Assignee, and Assignee desires to accept the transfer and assignment of, all of Assignors' worldwide right, title and interest in and to, the Intellectual Property.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration as set forth in the Agreement, the receipt and sufficiency of which are hereby acknowledged, Assignors hereby assign, transfer and set over to the Assignee all right, title and interest in and to the Intellectual Property, including, but not limited to, the right to apply for any patents, copyrights, trademarks, or other intellectual property rights anywhere in the United States and any and all foreign countries based upon any of the Intellectual Property. Exhibit A, attached hereto and incorporated herein, contains a non-exhaustive list of the registered Intellectual Property to be transferred under this Assignment.

Assignors hereby authorize Assignee to file patent applications, copyright registrations, trademark registrations, or any other applicable registrations in any and all countries based upon any or all of the Intellectual Property, in the individual inventors' names, in Assignors' name, in

Assignee's name or otherwise as the Assignee may deem appropriate or advisable, under applicable international convention or otherwise.

Assignors hereby represent and warrant that it has the full right and power to convey the entire right and interest herein assigned, that Assignors have granted no rights or interests to third parties that are inconsistent with the rights and interests granted herein, and that Assignors will not execute any instrument or grant or transfer any rights or interests inconsistent with the rights and interests granted herein.

Assignors hereby covenant and agree that it will, upon request of the Assignee, communicate to the Assignee any known facts relating to the Intellectual Property and the development history thereof, testify in any legal proceeding, execute all lawful papers and all rightful oaths and declarations, and generally do all further acts which may be deemed necessary by the Assignee to obtain and enforce proper protection for the Intellectual Property in all countries.

Capitalized terms not otherwise defined herein shall have the meanings set forth in the Agreement. The terms of the Agreement are incorporated herein by this reference. In the event of any conflict or inconsistency between the terms of the Agreement and the terms hereof, the terms of the Agreement shall govern.

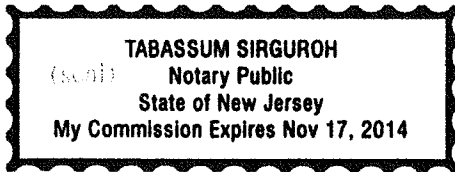

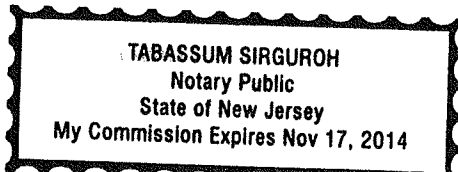

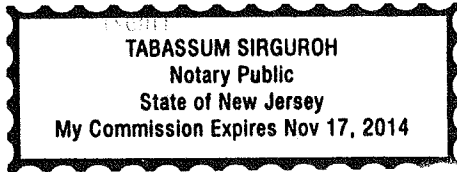
