I hereby authorize the responsible officer of the Patent and Trademark Office of the United States, and any official of any other country empowered to issue patents, to record this Assignment, and to issue or transfer all said Letters Patent on said design to the Assignee as owner of all right, title, and interest therein, or otherwise as the Assignee may direct, in accordance with the terms of this Assignment.
