ASSIGNMENT

WHEREAS, Pension Benefit Insurance Services, Inc., a corporation organized and existing under the laws of the State of New Jersey, having a principal place of business at Knoll Place, 70 Sparta Avenue, Suite 202, Sparta, New Jersey 07871-1760 (“ASSIGNOR”), previously acquired the entire right, title and interest in, to and under the inventions and in, to and under Letters Patent or similar legal protection obtained or to be obtained therefor in the United States and in any and all foreign countries, for the invention described in U.S. Patent Application Serial No. 10/414,355 filed on April 15, 2003, entitled METHODS FOR VALIDATING PARTICIPANTS IN A PENSION INSURANCE PROGRAM, and including all priority rights for other countries arising therefrom, all inventions therein disclosed, and any and all present or future applications to such inventions that may be filed in any country, inclusive of, but not limited to, continuations, continuations-in-part, divisions, substitutions, reexaminations, reissues, international applications filed under the Patent Cooperation Treaty, United States provisional patent applications, certificates of addition, utility models, and petty patents (collectively the “PATENT RIGHTS”);

WHEREAS, Pentech, LLC, a Delaware limited liability company, having a principal place of business at 8070 Park Lane, Suite 100, Dallas, Texas 75231 (“ASSIGNEE”) is desirous of acquiring all right, title and interest in said PATENT RIGHTS;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged,

ASSIGNOR hereby sells, assigns, transfers and sets over unto ASSIGNEE, its successors, legal representatives, and assigns, ASSIGNOR’s entire right, title and interest, including the right to sue for past damages, in, to and under the PATENT RIGHTS,

supplementary protection certificates related to the PATENT RIGHTS, and any related patent term extensions which may be granted for the PATENT RIGHTS; all of the above to be held and enjoyed by the ASSIGNEE for its own use and enjoyment to the full end of the term or terms for which such PATENT RIGHTS and related intellectual property rights may be granted, as fully and entirely as the same would have been held and enjoyed by ASSIGNOR had this Assignment and sale to ASSIGNEE not been made;

ASSIGNOR hereby covenants that ASSIGNOR has full right to convey the entire right, title and interest herein sold, assigned, transferred and set over;

AND ASSIGNOR hereby further covenants and agrees that ASSIGNOR will, at any time, when called upon to do so by the ASSIGNEE, its successors, legal representatives, or assigns, communicate to the ASSIGNEE, its successors, legal representatives, or assigns, as the case may be, any facts known to ASSIGNOR respecting said PATENT RIGHTS, and execute and deliver any and all lawful papers that may be necessary or desirable to perfect the title to said PATENT RIGHTS in the ASSIGNEE, its successors, legal representatives and assigns, and that if reissues of said PATENT RIGHTS or disclaimers relating thereto, or divisions, continuations, or refilings thereof, shall hereafter be desired by the ASSIGNEE, its successors, legal representatives, or assigns, ASSIGNOR will, at any time, when called up to do so by the ASSIGNEE, its successors, legal representatives, or assigns sign all lawful papers, make all rightful oaths, execute and deliver all such disclaimers and all divisional, continuation and reissue applications so desired, and do all lawful acts requisite for the application for such reissues and the procuring thereof and for the filing of such disclaimers and such applications, and generally do everything possible to aid the ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said PATENT RIGHTS in all

countries, and without further compensation but at the expense of the ASSIGNEE, its successors, legal representatives and assigns.
