ASSIGNMENT

WHEREAS, WE, David L. Kaplan, a United States citizen residing at 46 Pond Street, Concord, MA 01742 and Amanda Murphy, a United States citizen residing at 36R Marshall Street, Somerville, MA 02145, have invented certain new and useful improvements in DIAZONIUM SALT MODIFICATION OF SILK POLYMER, for which we have executed an application for Letters Patent in the United States filed as Application Serial Number 12/192,588 on August 15, 2008, and naming us as inventors;

AND WE HEREBY covenant and agree that we will communicate to the said Trustees of Tufts College, its successors, legal representatives and assigns, any facts known to us respecting said improvements and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said Trustees of Tufts College, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.


