## ASSIGNMENT AND AGREEMENT



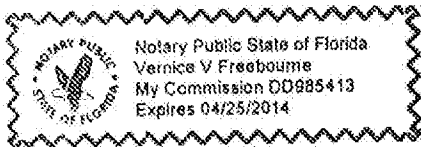
