**ASSIGNMENT**


This Assignment is made and effective as of the 10<sup>th</sup> day of May, 2004, by WIDCOMM, INC., a company organized and existing under the laws of California (hereinafter referred to as the "ASSIGNOR"), and BROADCOM CORPORATION, a company organized and existing under the laws of California (hereinafter referred to as the "ASSIGNEE").

ASSIGNOR was the surviving corporation in a merger between the ASSIGNOR and WC Acquisition Corporation, a California corporation and wholly owner subsidiary of Broadcom Corporation. ASSIGNOR is the owner of the entire right, title and interest in and to the United States Patents and Patent Applications listed in Exhibit A (hereinafter collectively referred to as the "Assigned Patents and Patent Applications").

In consideration of good and valuable considerations, the receipt and sufficiency whereof are hereby acknowledged, ASSIGNOR hereby assigns to ASSIGNEE, its successors and assigns, the entire right, title and interest in the invention or improvements disclosed in the Assigned Patents and Patent Applications, both United States and foreign, which either ASSIGNOR has filed or ASSIGNEE may file, on said invention or improvements, and in any and all Letters Patent of the United States and foreign countries, which may be obtained on any of said applications, and in any continuation, continuation-in-part, divisional, re-examination, reissue or extension of such applications or patents, and further assigns to said assignee the priority right provided by the International Convention. This assignment shall specifically include, without limitation, rights to collect damages and payments for past, present or future infringements or misappropriations of any Assigned Patent or Patent Application, if applicable.

The undersigned hereby authorizes and requests the Commissioner of Patents and Trademarks to issue said Letters Patent to said ASSIGNEE.
