PATENT ASSIGNMENT

THIS PATENT ASSIGNMENT ("Assignment") is made between BELLAMORA HOLDINGS, LLC, a Florida limited liability company (hereinafter "Assignor"), and BMH INVESTORS, LLC, a Florida limited liability company (hereinafter "Assignee").

WHEREAS, Assignor is the owner of all rights, title and interest to that certain United States Patent, as referenced below (hereinafter the "Patent");

WHEREAS, pursuant to a Patent Security Agreement, dated March 17, 2011 (the "Security Agreement"), among Assignor, Assignee, and Sollinger of Odessa Limited Partnership ("Sollinger"), Assignee and Sollinger (collectively, the "Lenders") have a first-priority security interest in the Patent to secure the payment of obligations specified in the Security Agreement (the "Secured Obligations").

WHEREAS, Assignor has failed to pay the Secured Obligations when due, and Lenders are entitled to foreclose on the Patent, and Lenders have demanded that the Patent be assigned and transferred to Assignee pursuant to the Security Agreement.

Assignor hereby covenants that Assignor has full right to convey the entire interest assigned and that Assignor has not executed and will not execute an agreement in conflict herewith.
