
1. Said invention in **METHODS AND SYSTEMS RELATED TO ESTABLISHING GEO-FENCE BOUNDARIES**.



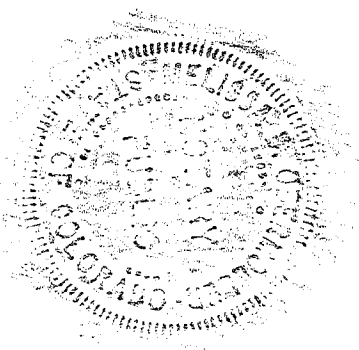


