ARTICLES OF INCORPORATION

Pursuant to the provisions of Title 10 of the Arizona Revised Statutes or the Arizona Business Corporation ABCA (the "ABCA"), the Amended and Restated Articles of Incorporation of Veeco Metrology Inc., an Arizona corporation, dated as of August 3, 1989, as amended from time to time, shall be amended and restated in their entirety as set forth herein.

ARTICLE I - NAME

The name of the corporation is Bruker Nano, Inc.

ARTICLE II - PURPOSE

The purpose for which the corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Arizona as they may be amended from time to time.

ARTICLE III - INITIAL BUSINESS

The character of the business which the corporation initially intends to conduct in the State of Arizona is the business of manufacturing and sale of optical equipment and related activities.

ARTICLE IV - PLACE OF BUSINESS

The initial place of business of the corporation is 2650 East Elvira Road, Tucson, AZ 85706.

ARTICLE V - AUTHORIZED CAPITAL

The corporation shall have authority to issue one thousand (1,000) shares of common stock, each share having a par value of one cent (\$.01) per share, designated as "Common Stock".

ARTICLE VI - STATUTORY AGENT

The name and address of the initial statutory agent of the corporation is CT Corporation System, 2394 E Camelback Rd, Phoenix, AZ 85016-3429. The name of the corporation's registered agent is the CT Corporation System.

ARTICLE VII - BOARD OF DIRECTORS

The initial Board of Directors shall consist of two (2) directors, but the number of persons to serve on the Board of Directors thereafter shall be fixed by the Bylaws of the corporation. The persons who are to serve as directors until the annual meeting of the shareholders or until their successors are elected and qualified, are:

ARTICLE VIII - REPURCHASE OF SHARES

The Board of Directors of the corporation may, from time to time, cause the corporation to purchase its own shares to the extent of the unreserved and unrestricted earned and capital surplus of the corporation.

ARTICLE IX - INDEMNIFICATION

The present and former officers and directors of the corporation may be indemnified against, if the Board of Directors shall so resolve, and they shall not be liable to third parties for, any or all claims made against them in such capacity, and present or former directors of the corporation shall not be liable to the corporation or its shareholders for monetary damages for breach of fiduciary duty, all to the greatest extent permitted by law. If subsequent legislation permits the corporation to indemnify, exculpate or limit the liability of its present and former officers and directors to a greater extent than is currently permitted under existing law, then the corporation shall indemnify, exculpate and limit the liability of its present and former officers and directors to the extent permitted by such subsequent legislation. The power of indemnification, the right of exculpation and the limitation of liability set forth above under the ABCA shall not be denied or limited by the Bylaws.

ARTICLE X - EXCULPATION

To the fullest extent permitted by the ABCA as the same exists or may hereafter be amended, no director shall be liable to this Corporation or its shareholders for monetary damages for breach of fiduciary duty as a director.

No repeal or modification of the foregoing paragraph by the shareholders of this Corporation shall adversely affect any right or protection of a director existing at the time of such repeal or modification.

ARTICLE X - BYLAWS

The Board of Directors of the corporation shall have the power to adopt, amend or repeal from time to time the Bylaws of the corporation.
