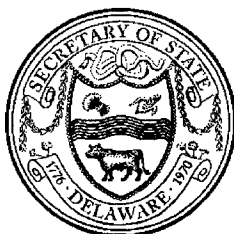

Dachis Corporation, a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "*Company*"),

**DOES HEREBY CERTIFY:**

**FIRST:** That the Company is incorporated pursuant to the General Corporation Law of the State of Delaware.

**SECOND:** That the Company owns One Hundred Percent (100%) of the outstanding shares of the capital stock of XPLANE Corp., a corporation incorporated on the 27th day of August, 2007 pursuant to the provisions of the General Corporation Law of the State of Delaware ("*Subsidiary*").

**THIRD:** That the Company, pursuant to the following resolutions duly adopted by the Board of Directors of the Company by unanimous consent on December 28, 2011, filed with the minutes of the Board of Directors of the Company, determined to merge Subsidiary with and into the Company, on the terms and conditions set forth in such resolutions:

**WHEREAS,** the Company lawfully owns One Hundred Percent (100%) of the outstanding shares of the capital stock of XPLANE Corp., a corporation incorporated pursuant to the provisions of the General Corporation Law of the State of Delaware ("*XPLANE*"); and

**WHEREAS,** the Company desires to merge XPLANE with and into the Company and to assume all of the XPLANE's liabilities, obligations and assets;

**NOW, THEREFORE, BE IT**

**RESOLVED,** that the Company merge XPLANE with and into the Company and assume all of XPLANE's liabilities, obligations and assets; and further

**RESOLVED**, that the Chief Executive Officer or the President of the Company be, and each hereby is, authorized, directed and empowered to execute and deliver a Certificate of Ownership and Merger, and the Secretary or Assistant Secretary of the Company be, and each hereby is, authorized, directed and empowered to acknowledge such Certificate of Ownership and Merger, setting forth a copy of the resolution to merge XPLANE with and into the Company, effective as of 11:59 p.m. on December 31, 2011, and to assume the liabilities, obligations and assets of XPLANE, and the date of adoption thereof, and to file the same in the office of the Secretary of State of Delaware and a certified copy thereof in the office of the Recorder of Deeds of the County of New Castle, and elsewhere as may be required by law; and further

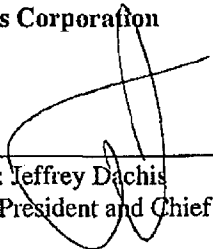
