ASSIGNMENT

I further hereby sell, assign and transfer to said ASSIGNEE whatever cause of action I may have for past or present infringement of said design or patents, together with the right to bring suit for any such infringement and to seek and receive damages and other relief arising from any such infringement.

TO BE HELD AND ENJOYED by said ASSIGNEE, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by us had no sale and assignment of said interest been made;




