ASSIGNMENT

WHEREAS We, **Chikashi Yoshinaga** and **Nobuyuki Nakasawa** of c/o Intellectual Property H.Q., SANYO Electric, Co., Ltd. 5-5, Keihan-hondori 2-chome, Moriguchi-shi, Osaka, Japan (hereinafter referred to as "ASSIGNORS") have invented certain new and useful improvements in:

called upon to do so by the said ASSIGNEE, its successors or assigns, and that We will, at the cost and expense of the said ASSIGNEE fully assist and cooperate in all matters in connection with the United States and foreign applications and patents issuing thereon.
