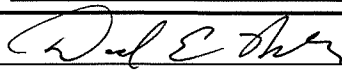

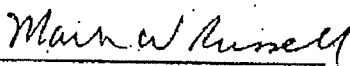
THIRD: The name of the surviving corporation shall be changed to Electrolux Home Care Products, Inc. immediately upon the merger.

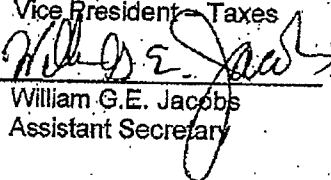
FOURTH: The merger is to become effective on June 29, 2007.
