
ASSIGNMENT

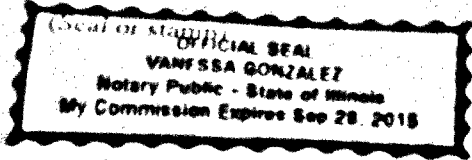

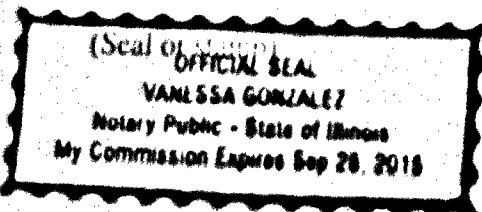

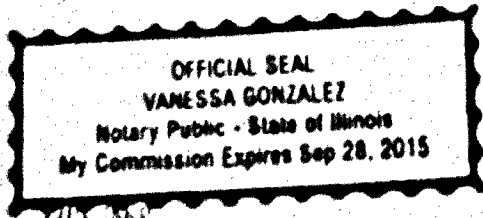
