TERMINATION OF SECURITY INTEREST IN PATENTS

This **TERMINATION OF SECURITY INTEREST IN PATENTS**, dated as of June 15, 2012, is made by **SILICON VALLEY BANK**, a California corporation (the "Secured Party"), in favor of **WAVELINK CORPORATION**, a Washington corporation (the "Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement dated as of June 25, 2010 (as amended, restated, supplemented, or modified from time to time, the "Intellectual Property Security Agreement"; capitalized terms used herein without definition shall have the meanings ascribed thereto in the Intellectual Property Security Agreement) by and among Secured Party and Grantor, Grantor has granted a security interest in certain personal property to Secured Party, including without limitation a security interest in certain Patents;

WHEREAS, the Intellectual Property Security Agreement was recorded at the United States Patent and Trademark Office on or about July 6, 2010 at Reel 024630, Frame 0981; and

WHEREAS, Secured Party has agreed to terminate and release its security interest in all of the Patents, including, without limitation, the Patents identified on Schedule A attached hereto.

NOW, THEREFORE, for valuable consideration, Secured Party hereby terminates and releases all mortgages, liens, collateral assignments, pledges and security interests granted to Secured Party in the Patents, including, without limitation, the following:

1. all of Grantor's patents and patent applications to which Grantor is a party including those referred to on Schedule A attached hereto;
2. all divisionals, continuations, continuations-in-part, reissues, reexaminations, or extensions of the foregoing;
3. all products and proceeds of the foregoing, including any claim by Grantor against third parties for past, present or future infringement of any Patent, including the right to receive damages; and
4. all licenses or other rights to use any of the Patents and all license fees and royalties arising from such use to the extent permitted by such license or rights.

Secured Party hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Secured Party, any and all of Secured Party's right, title and interest in, to and under the Patents.

Secured Party agrees, at the Grantor's expense, to cooperate with Grantor and to provide Grantor with the information and additional authorization reasonably requested by Grantor to effect the release of the Secured Party's security interest in and lien on the Patents.


This agreement and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of California.
