AND ASSIGNOR HEREBY covenants that it has full right to convey the entire interest herein assigned and that it has not executed and will not execute any agreement in conflict herewith; and agrees that it will communicate to ASSIGNEE any and all facts known to it regarding said invention and improvements and applications whenever requested and will testify in any legal proceeding, sign all lawful papers, execute all divisional, reissue, continuation, or any other applications, and generally do everything possible to aid ASSIGNEE to obtain and enforce proper patent protection for said invention and improvements in all countries.

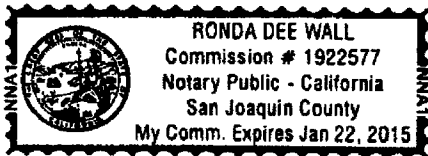
