PATENT ASSIGNMENT

THIS PATENT ASSIGNMENT (this "*Assignment*") effective as of 11:59 p.m. May 24, 2012 (the "*Effective Date*"), is by and between TERRY LOVETT, an individual having an address of 1431 Sea Ridge Drive, Newport Beach, California 92006 ("*Assignor*"), and CDL ENTERPRISES, LTD., a California corporation having an address of 1431 Sea Ridge Drive, Newport Beach, CA 92660 ("*CDL*") ("*Assignee*"). Assignor and Assignee are sometimes referenced collectively as the "*Parties*".

RECITALS

WHEREAS, Assignor is the owner of all right, title and interest in and to the patents and corresponding inventions disclosed therein as listed in EXHIBIT A attached hereto and incorporated herein by reference (the "*Patents*"); and

WHEREAS, Assignor desires to assign to Assignee, and Assignee desires to acquire, all of Assignor's rights, title and interest in and to the Patents.

NOW, THEREFORE, in consideration of the premises, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. ASSIGNMENT.

Assignor hereby sells, assigns, transfers, conveys, and delivers to Assignee, its successors, and assigns, all of Assignor's rights, title, and interest in, to, and under, the Patents, including all divisions, reissues, reexaminations, continuations, continuations-in-part, renewals, and extensions thereof, and all patents or similar legal protection issuing thereon, and in and to all income, royalties, damages, claims, and payments now or hereafter due or payable with respect to any of the foregoing, and in and to all causes of action, either at law or in equity, for past, present, or future infringement of any of the foregoing, and in and to all rights corresponding to the foregoing throughout the world. Assignor, for itself and its successors and assigns, covenants and agrees to warrant and defend the transfer, assignment and conveyance of the Patents and the rights assigned herein to Assignee and its successors and assigns against all claims and demands.

2. RECORDALS/FURTHER ASSURANCES.

Assignee (or its designee or transferee) shall record this Assignment with the U.S. Patent and Trademark Office and the Canadian Intellectual Property Office. Assignor shall execute and deliver to Assignee all such further instruments, assignments, assurances and other documents, and perform such other acts, as Assignee may reasonably request or as may be necessary to more fully assign and convey to and vest in Assignee the rights herein assigned.

3. ORIGINALS/COUNTERPARTS.

This Assignment may be executed by facsimile signature in multiple counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same instrument.
