WHEREAS, We, CHAD H. JONES, a citizen of the United States of America and a resident of Frisco, Texas, and JUSTIN D. PENDLETON, a citizen of the United States of America and a resident of The Colony, Texas (hereinafter referred to as "ASSIGNORS") have invented a new, original, and ornamental design for a "SWIVEL AERATOR" for which application has been filed in the U.S. Patent Office; and


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNORS do hereby sell, assign and transfer unto said ASSIGNEE, its successors, assigns and legal representatives, as of the date set forth below, the full and exclusive right, title and interest in and to said design and in and to said application and all patents which may be granted therefor, and all divisions, reissues, substitutions, continuations, continuations-in-part and extensions thereof; and we hereby authorize and request the Commissioner of Patents and Trademarks to issue all patents for said design, or patents resulting therefrom, insofar as our interest is concerned, to the said ASSIGNEE;

ASSIGNORS also hereby convey and assign to said ASSIGNEE, its successors, assigns and legal representatives the full and exclusive rights, title and interest to the design disclosed in said application throughout the world, including the right to file applications and obtain patents, models, and drawings for said design in its own name throughout the world including all rights of priority, all rights to publish cautionary notices reserving ownership of said design and all rights to register said design in appropriate registries, and all rights to enforce said rights against others and recover damages for infringement thereof at any time; and ASSIGNORS further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other

papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.

ASSIGNORS hereby further agree to communicate to said ASSIGNEE, or to its successors, assigns and legal representatives, any facts known to ASSIGNORS respecting any design modifications; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said design in all countries. ASSIGNORS further represent that ASSIGNORS own the rights being conveyed by this Assignment and have not previously encumbered or assigned to any person or entity other than ASSIGNEE any right that is being assigned to ASSIGNEE herein.

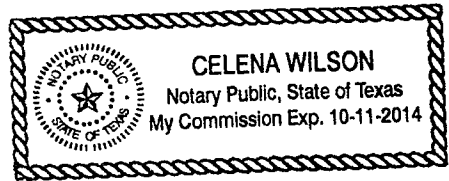
