NOTICE OF SECURITY INTEREST

Tecnocap LLC, a Delaware limited liability company (together with its successors and permitted assigns, "Debtor"), and The Huntington Capital Investment Company II, an Ohio corporation (together with its successors and assigns, "Secured Party"), are parties to a certain Continuing Security Agreement dated June 21, 2012 (the "Security Agreement").
