## ASSIGNMENT

5. To the extent any intellectual property rights related to **METHODS AND SYSTEMS FOR POWER RESTORATION PLANNING** are not assigned under sections 1-9 above, cannot be assigned under sections 1-9 above, or are subsequently deemed not to be assigned under sections 1-9 above, ASSIGNOR grants to ASSIGNEE a worldwide, royalty-free, perpetual, non-terminable, transferrable, exclusive license to manufacture, have manufactured, use, distribute, have distributed, use, offer for sale, sell, rent, lease, loan, export and/or import. ASSIGNOR further grants to ASSIGNEE, a worldwide, royalty-free, perpetual, non-terminable, transferrable, exclusive license, with the right to sublicense (including the right to sublicense through multiple levels of sublicensees), to any right(s) ASSIGNOR may have in intellectual property rights related to **METHODS AND SYSTEMS FOR POWER RESTORATION PLANNING**, including the rights: (i) to use, copy, create derivative works of, publicly display, publicly perform, and distribute such IP Rights; and (ii) to use, copy, create derivative works of, publicly display, publicly perform, distribute, make, have made, sell, have sold, import and otherwise dispose of such intellectual property rights, without attribution or reference to source.

To the extent any intellectual property rights related to **METHODS AND SYSTEMS FOR POWER RESTORATION PLANNING** are not exclusively licensed under section 10 above, cannot be exclusively licensed under section 10 above, or are subsequently deemed not to be exclusively licensed under section 10 above, ASSIGNOR grants to ASSIGNEE a worldwide, royalty-free, perpetual, non-terminable, transferrable, non-exclusive license to manufacture, have manufactured, use, distribute, have distributed, use, offer for sale, sell, rent, lease, loan, export and/or import. ASSIGNOR further grants to ASSIGNEE, a worldwide, royalty-free, perpetual, non-terminable, transferrable, non-exclusive license, with the right to sublicense (including the right to sublicense through multiple levels of sub-licensees), to any right(s) ASSIGNOR may have in intellectual property rights related to **METHODS AND SYSTEMS FOR POWER RESTORATION PLANNING**, including the rights: (i) to use, copy, create derivative works of, publicly display, publicly perform, and distribute such IP Rights; and (ii) to use, copy, create derivative works of, publicly display, publicly perform, distribute, make, have made, sell, have sold, import and otherwise dispose of such intellectual property rights, without attribution or reference to source.
