ASSIGNMENT OF PATENT RIGHTS

This ASSIGNMENT OF PATENT RIGHTS (this "Assignment"), dated December 24, 2003, is entered into by MedImmune Limited, a England and Wales corporation ("Assignor"), for the benefit of Amgen Inc, a Delaware corporation ("Assignee"). Capitalized terms used but not defined herein, if any, shall have the meanings ascribed to such terms in the AMENDED AND RESTATED LICENSE AND COLLABORATION AGREEMENT (as defined below).

WHEREAS, Assignor and Assignee have entered into that certain AMENDED AND RESTATED LICENSE AND COLLABORATION AGREEMENT dated December 24, 2003 (the "Collaboration Agreement"); and


WHEREAS, pursuant to the Collaboration Agreement, Assignor agreed to assign, and the Assignee agreed to acquire, all of Assignor's right, title and interest, in, to and under the patent applications set forth on Schedule A.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Assignor has sold, assigned, transferred and set over, and by these presents does hereby sell, assign, transfer and set over, unto Assignee, its successors, legal representatives and assigns, all of Assignor's right, title and interest, in, to and under the patent applications set forth on Schedule A and all patents of the United States which may be granted thereon, and all divisions, renewals, continuations, and substitute applications thereof, and all patents worldwide that may be granted thereon, and all reissues, reexaminations, and extensions thereof, together with the right to file such applications and the right to claim for the same the priority rights derived from such patent application under the patent laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable, each of the foregoing including, to the extent applicable, the right to seek damages and/or injunctive relief in the event of infringement of any such issued patent, with the right to sue for and receive the same for Assignee's own account and use, solely to the extent such infringement occurs from and after the Effective Date, and, to the extent set forth above, for the use and on behalf of its successors and assigns.




