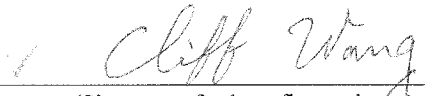
ASSIGNMENT DEED

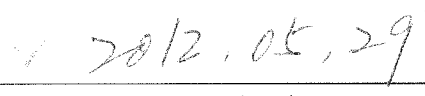
