and assigns, or its nominees, in the United States and in all other countries where HANUMAN LLC may desire to have the said inventions, or any of them, patented, with specifications and claims in such form as shall be approved by counsel for HANUMAN LLC, and to vest and confirm in HANUMAN LLC, its successors and assigns, or its nominees, the full and complete legal and equitable title to all such Letters Patent, without further consideration than now paid but at the expense of HANUMAN LLC, its successors and assigns.



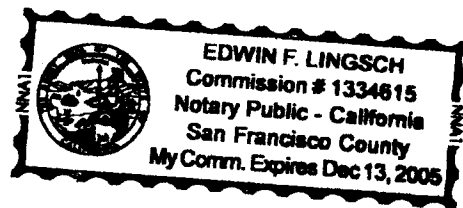

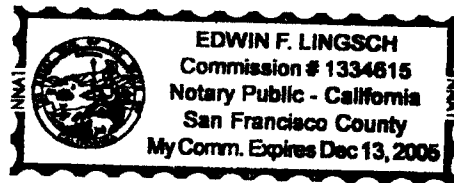
