("ATMI"), a Delaware corporation having an office at 7 Commerce Drive, Danbury, CT 06810 is the owner, by prior assignment, of all right, title, and interest in and to U.S. Patent Nos. 7,166,732; 7,241,912; 7,371,880; and 7,531,031; and pending U.S. Patent Application No. 12/464,088 filed May 11, 2009, such U.S. patents and U.S. patent application hereinafter being referred to as the "Patent Rights."

Subject to and in effectuation of the terms and provisions of the PATENT ASSIGNMENT and LICENSE AGREEMENT executed on June 27, 2012 by ATMI and ROHM AND HAAS ELECTRONIC MATERIALS LLC ("RHEM"), a Delaware limited liability company having an office at 455 Forest Street, Marlborough, MA 01752, and in consideration of the mutual promises, covenants, and undertakings set forth in such PATENT ASSIGNMENT and LICENSE AGREEMENT, including the grant by RHEM to ATMI of certain license rights in the Patent Rights thereunder, ATMI hereby (i) assigns to RHEM all of ATMI's right, title, and interest in and to the Patent Rights, and subsequent thereto (ii) acknowledges and accepts the grant to ATMI by RHEM of certain license rights in the Patent Rights, as specified in the PATENT ASSIGNMENT and LICENSE AGREEMENT.
