ASSIGNMENT

For good and valuable consideration, and in accordance with my/our agreement(s) with Bayer Healthcare, LLC, a corporation of the State of Delaware, USA, I/we, the undersigned, hereby sell, assign and transfer to Bayer Healthcare, LLC, its successors and assigns ("Bayer"), my/our entire right, title and interest in and to any and all inventions described in the application for United States Letters Patent that is being executed by me/us herewith and entitled:
