ASSIGNMENT OF PATENT APPLICATION

WHEREAS, I, having post office addresses that follow my name: Chia-Chun Hsu, 16F, -3, No.329, Sec. 2, Fuxing S. Rd., Taipei City 106, Taiwan (hereinafter referred to as ASSIGNOR), am the joint inventor (along with Hung-Yu Wei, Guan-Yu Lin, and Ching-Chun Chou) of an invention described and claimed in the specification forming part of the United States patent application entitled "ENHANCED PAGING MECHANISM FOR MACHINE TYPE COMMUNICATION," executed herewith;

ASSIGNORS hereby authorize and request the Commissioner of Patents and Trademarks to issue all letters patents on said invention to ASSIGNEE. ASSIGNORS agree to execute all instruments and documents required for the making and prosecution of applications for United States and foreign letters patents on said invention, for litigation regarding said letters patents, or for the purpose of protecting title to said invention or letters patents therefor.
