SETTLEMENT AGREEMENT

This SETTLEMENT AGREEMENT ("Settlement Agreement"), is made this February 20, 2012 (the "Effective Date") by and between Aquasana, Inc. (f/k/a Sun Water Systems, Inc.), having a place of business at 6034 Courtyard Drive, Suite 370, Austin, TX 78730 ("Aquasana"), Chien Hun Yang (a/k/a Johnston Young) ("Yang"), and An Axon Industry Company Ltd., having a place of business at Room 14-1, NO. 296, Chung-Shan Road Sec 2, Chung-He City, Taipei County, 23557 Taiwan, R.O.C., on behalf of itself and its officers, directors, employees, agents, and representatives (collectively, "Axon" and together with Aquasana and Yang, each a "Party" and collectively, the "Parties").

To the extent he has not already done so by virtue of his relationship with Axon and the June 7, 2011 Assignment, Yang hereby assigns to Aquasana his entire right, title, and interest (if any) in all intellectual property rights (including all copyright rights, trademark rights, trade secret rights, patent rights, and all other comparable rights recognized anywhere in the world) in the subject matter of each of the US Applications, including without limitation the right to pursue intellectual property protection for the subject matter of each of the US Applications everywhere in the world.
