NOTICE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This NOTICE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "Agreement") is made this 5th day of July, 2012, by Lucid, Inc., a New York corporation ("Borrower"), in favor of Northeast LCD Capital, LLC, a Maine limited liability company ("Lender"), pursuant to that certain Loan and Security Agreement dated as of July 5, 2012 by and among Borrower and Lender (as at any time prior to the date hereof amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Loan and Security Agreement").

WHEREAS, Borrower is the owner of (a) certain trademarks, service marks, trade names, trade dress, Internet domain names or other indicia of trade origin, whether registered or unregistered, trademark and service mark registrations, and applications for trademark or service mark registrations and any renewals thereof, including, without limitation, each registration and application identified in Exhibit A attached hereto and made a part hereof, and including without limitation the goodwill of the business connected with the use of, and symbolized by, each such trademark, service mark, trade name, trade dress, Internet domain name or other indicia of trade origin (the "Marks"), (b) certain patents, patent applications and patentable inventions, including, without limitation, each patent identified in Exhibit B attached hereto and made a part hereof, and including without limitation all inventions and improvements described and claimed therein and the right to make, have made, use or sell market or advertise for sale the same, and all reissues, divisions, continuations, continuations-in-part, substitutes, renewals and extensions thereof and all improvements thereon (the "Patents"), (c) certain copyrights, copyrights of works based on, incorporated in, derived from or relating to works covered by such copyrights and all right, title and interest to make and exploit all derivative works based on or adopted from works covered by such copyrights, including, without limitation, the copyrights in each original work of authorship identified in Exhibit C attached hereto and made a part hereof, and including without limitation the right to exercise any or all of the exclusive rights of a copyright owner with regard to the foregoing (the "Copyrights"), and (d) for each Mark, Patent and Copyright, (i) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations thereof, (ii) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof), and (iii) all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of the Grantor accruing thereunder or pertaining thereto (together with the Trademarks, Patents and Copyrights, the "Intellectual Property");

WHEREAS, Lender has agreed to extend certain credit facilities to Borrower pursuant to the Loan and Security Agreement on the condition that Borrower grant to Lender a security interest in and to certain assets of Borrower, including, without limitation, in and to the Intellectual Property and all proceeds thereof and all other related claims and rights;

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, as security for the

due and timely payment and performance of the Obligations, Borrower and Lender agree as follows:

1) Grant of Security Interest. Borrower hereby grants to Lender a security interest in and to the Intellectual Property and all proceeds thereof and gives notice of such security interest and the existence of such Loan and Security Agreement providing therefor.

2) Purpose. Borrower has entered into this Agreement for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office and the United States Copyright Office. The security interest granted hereby has been granted to the Lender in connection with the Loan and Security Agreement and is expressly subject to the terms and conditions thereof.

3) Definitions. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Loan and Security Agreement.

4) Execution in Counterparts. This Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
