ASSIGNMENT

WHEREAS, Junichiro OYA, hereinafter called the "Assignor", have made the invention described in the United States patent application entitled CAPACITANCE-TYPE PROXIMITY SENSOR DEVICE AND ELECTRONIC APPARATUS USING THE SAME, executed by Assignor on the same date as this Assignment;

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
