## **RELEASE OF LIEN ON PATENTS**

**WHEREAS**, the Patent Assignment was recorded on January 9, 2007 in the United States Patent and Trademark Office under Reel 018734, Frame 0027.


**WHEREAS**, Lender has agreed to release its security interest in the Patent Collateral covered by the Patent Assignment.
