## ASSIGNMENT

WHEREAS, I, MATHIEU LION and BÉRENGÈRE SUQUET, residing at 184 rue Legendre, 75017 Paris, France, and 60 avenue Simon Bolivar, 75019 Paris, France, both citizens of France, have invented a new and useful design for BOWL, for which application papers for United States Letters Patent are being filed herewith; and
