## ASSIGNMENT

Warren and James William Phillips, covenant and agree with said Cameron Health, Inc., its successors and assigns, that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been made to others by us and that full right to convey the same as herein expressed is possessed by us.

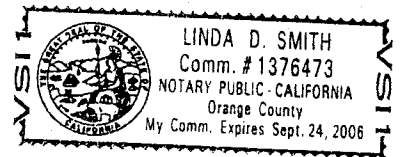

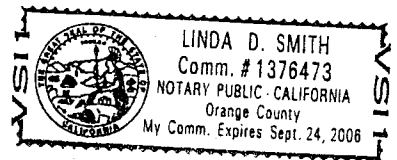
