## ASSIGNMENT

WHEREAS, WE, MATHIEU LION, residing at 9 Cite Aubry, 75020 Paris, France and MARIE BUET, residing at 13 rue Guenot, 75011 Paris, France, both citizens of France, have invented a new and useful design for ROLLING CUTTER, for which application papers for United States Letters Patent are being filed herewith; and

WHEREAS, MASTRAD, S.A., a corporation organized and existing under and by virtue of the laws of France and having its place of business at 32 bis-34 boulevard de Picpus, 75012 Paris, France, is desirous of acquiring the exclusive right, title and interest in and to said invention and in and to the Letters Patent to be granted and issued therefor in the United States of America and its territories and possessions, and all countries foreign thereto:

NOW, THEREFORE, for a valuable consideration, the receipt of which is hereby acknowledged, we, MATHIEU LION and MARIE BUET, do hereby sell, assign, transfer, and set over unto the said MASTRAD, S.A., its successors and assigns, the full and exclusive right, title, and interest in and to the said invention, and in and to any and all Letters Patent to be granted and issued therefor, not only for, to and in the United States of America, its territories and possessions, but for, to and in all other countries including all priority rights under the International Convention; and we hereby authorize and request the Commissioner of Patents and Trademarks to issue said Letters Patent to said MASTRAD, S.A., its successors and assigns, in accordance with this Assignment.
