

ASSIGNMENT

WHEREAS, we, Matthew J. FRIEND, a citizen of the United States, Douglas A. DREW, a citizen of the United States, Gerardo AGUIRRE, a citizen of the United States, and Ronald B. EASTER, a citizen of the United States hereinafter "ASSIGNORS", have, along with other co-inventors David J. Newman and Garrett J.
