## ASSIGNMENT

WHEREAS, Urban Nilsson, a Swedish citizen, residing in Sweden, (individual(s) hereinafter "ASSIGNOR") invented certain new and useful improvements, technology, inventions, developments, ideas or discoveries related to THE SYSTEM AND METHOD FOR PLANNING AND/OR PRODUCING A DENTAL PROSTHESIS which was described in International Patent Application No. PCT/EP2010/006929, filed November 15, 2010, for which we have filed National Phase Application No. 13/509,472 (hereinafter the "Application") for Letters Patent in the United States on May 11, 2012;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I, said inventor, do hereby acknowledge that I have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto said ASSIGNEE, its successors, legal representatives and assigns, the entire right, title, and interest throughout the world in, to, and under said improvements and said Application including all provisional applications, international applications, and foreign applications relating thereto (including, but not limited to, International Application No. PCT/EP2010/006929 filed on November 15, 2010 and European Application No. 09014296.9 filed on November 16, 2009) and all divisions, continuations, and continuations-in-part thereof, whether now pending or filed in the future and regardless of issuance status, and all Letters Patent of the United States which may be granted thereon and all reissues, reexaminations, renewals, and extensions thereof, and all rights of priority under International Conventions and applications for Letters Patent which may have been filed or which may hereafter be filed for said improvements in any country or countries foreign to the United States and all divisions, continuations, continuations-in-part, reissues, reexaminations, renewals, and extensions thereof; and I hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said improvements to said ASSIGNEE, its successors, legal representatives, and assigns, in accordance with the terms of this instrument.

AND ASSIGNOR DOES HEREBY sell, assign, transfer, and convey to ASSIGNEE, its successors, legal representatives, and assigns all claims for damages and all remedies arising out of any violation of the rights assigned hereby that may have accrued prior to the date of assignment to ASSIGNEE, or may accrue hereafter, including, but not limited to, the right to sue for, collect, and retain damages for past infringements of said Letters Patent before or after issuance.

AND ASSIGNOR DOES HEREBY covenant and agree that ASSIGNOR will communicate to said ASSIGNEE, its successors, legal representatives and assigns, any facts known to ASSIGNOR respecting the Work, and testify in any legal proceeding, assist in the preparation of any other provisional or non-provisional applications relating to the Application and the Work or any improvements made thereto, sign all lawful papers, execute and make all rightful oaths and/or declarations in connection with the Application and the Work including any improvements made thereto, any patent applications filed therefrom, and any continuing application filed from any of the aforementioned applications, and generally do everything possible to aid the ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for the Work in all countries.
